ARTS AND CRAFTS APPLICATION

JURIED SHOW



GROUNDS: Held in downtown Bandera on the Courthouse lawn.

ELIGIBILITY: Open to individual artists and craftsmen presenting their original works. No manufactured, imported or resale items will be allowed **in the Arts and Crafts area** – only original works and prints by exhibiting artists. Demonstrating your art or craft, while not required, will be a consideration when booths are being assigned. To maintain the quality and balance of the Arts and Crafts shown, this will be a juried show. The Bandera County Chamber of Commerce reserves the right to reject any display that is not in keeping with the examples submitted to jury. A Commercial area will be included in the event.

ABOUT THE SELECTION PROCESS: You select the pictures/web site or samples presented for consideration for our show. A picture of your typical booth setup is recommended. Be sure you send clear pictures that compliment your work. We prefer photos by e-mail and/or your web address if you have photos online.

REGISTRATION: The registration fee is \$130.00 per space for the two-day show. There will be no price limit on your items sold and no commission will be taken. All registration forms must be accompanied by photographs (returned with S.A.S.E. only) and/or a web link or e-mailed photos, and a check or money order payable to the Bandera County Chamber of Commerce. **Your check will not be cashed until you have been accepted into the show. Deadline for application is August 27th, 2021. You will receive acknowledgement of receipt of your application by e-mail.**

SPACES: Open spaces *only* are provided and are 10'x10'. You provide your own canopy. If you plan to use a canopy, tent, or umbrella, please specify and give dimensions. There are a limited number of spaces available. Electricity is available on a strictly limited basis at an additional charge of \$10 per space, only to those *demonstrating* an art or craft. Contact the Event Coordinator for additional information.

NOTIFICATION OF ACCEPTANCE: Artists will be notified of their acceptance by e-mail normally within a week of receipt of your application but no later than Monday, August 30th, 2021. You will receive an information packet no later than 24 hours prior to the event. ***There will be no refunds after September, 3rd, 2021, and no refunds should bad weather occur.***
